### 16/52 APOLOGIES FOR ABSENCE

## 16/53 DECLARATIONS OF INTEREST

## 16/54 REPRESENTATIONS FROM THE PUBLIC

### 16/55 POLICE REPORT

## 16/56 COUNTY COUNCILLOR'S REPORT

Councillor Bell informed that there was very little to report due to the forthcoming local elections and due to purdah. One item that could potentially affect the area, but was located outside of the Parish area was a planning proposal for a piggery at New Brancepeth which would see the intensive farming of upto 4000 pigs. There had already been much opposition to the application and a public meeting had been arranged for 26 April at 7 p.m. in New Brancepeth. It was hoped that a officers from planning, environmental health, highways and the agent of the applicant would be in attendance. Councillor Bell had asked the County Council for the matter to be heard by a Planning Committee.

### 16/65 VILLAGE MATTERS

- (i) Councillor Kemp informed the Council that the Happy Bears playgroup at Bearpark Primary School would continue under new management.
- (ii) Councillor Hull informed the Council that there was a real possibility that St. Edmunds Church could close after Christmas 2017 due to a number of factors, however, the congregation had decreased to almost single figures. Discussions would be taking place over the coming months within the Church, however, the future of the Church was very uncertain. The Council discussed the potential closure and were extremely concerned about the loss of the building and

queried whether the churchyard would remain open or closed and who would be responsible thereafter. Questions were also raised about the war memorial inside the church. The Clerk advised the Council that there was provision for the Parish Council to nominate buildings or land as assets of community value.

An asset could be listed if its use furthers (or had recently furthered) the community's social well-being or social interests (which include cultural, sporting or recreational interests) and would likely to do so in the future. Whilst the full detail of registering community asset would need to be looked into, the Clerk understood that when a listed asset comes to be sold, a moratorium on the sale (of up to six months) may be invoked, providing local community groups with a better chance to raise finance, develop a business and to make a bid to buy the asset on the open market.

# Resolved

That the Council note the information and that the Clerk seek further guidance in terms of registering an asset and what would be required.
